

MEMORANDUM OF ASSIGNMENT OF LEASE AGREEMENT

THIS MEMORANDUM OF ASSIGNMENT OF LEASE AGREEMENT is made and entered into as of October 30 2012, by and between RAIL CONNECTION, INC., a West Virginia corporation, with an address at 737 Eleanor Industrial Park, Eleanor, WV 25070 ("Assignor") and THE HUNTINGTON NATIONAL BANK, a national banking association, with an address at 105 East Fourth Street, Suite 200C, Cincinnati, OH 45202 ("Assignee"), with reference to the following:

Assignor and Severstal Dearborn Inc., a Delaware corporation ("Lessee") executed that certain Master Railroad Equipment Lease dated as of October 14, 2009, as amended from time to time and, pursuant thereto, that certain Schedule No. 05 dated September 27, 2010 (collectively, the "Lease"), pertaining to the railcars described on Exhibit A attached hereto (the "Railcars").

Assignor, as assignor, and Assignee, as assignee, executed that certain Assignment dated as of October 1, 2010 (the "Assignment"), pursuant to which (a) Assignor has assigned to Assignee all of Assignor's rights and obligations under the Lease and Assignee has assumed from Assignor all of Assignor's rights and obligations under the Lease, in each case, solely with respect to the assigned Railcars, and (b) Assignor has sold the assigned Railcars to Assignee.

The parties hereto wish to show for public record this Memorandum of Assignment of Lease Agreement to provide notice of such assignment.

This Memorandum of Assignment of Lease Agreement relates only to the sale by Assignor to Assignee of the assigned Railcars described herein and the assignment by Assignor to Assignee of the Lease solely as it pertains to such Railcars.

This Memorandum of Assignment of Lease Agreement may be executed in any number of counterparts, each executed counterpart constituting an original but all together only one Memorandum of Assignment of Lease Agreement.
