

BILL OF SALE, RELEASE AND TERMINATION

FOR VALUABLE CONSIDERATION, the receipt and sufficiency of which are hereby acknowledged, Wilmington Trust Company, not in its individual capacity but solely as Owner Trustee (the "Lessor") under that certain Equipment Lease Agreement (GATC Trust No. 92-1B) between the Lessor and General American Transportation Corporation (n/k/a GATX Corporation) (the "Lessee") dated as of July 1, 1992 (the "Lease"), which Lease was filed with the Surface Transportation Board on August 12, 1992 under recordation #17913, does hereby grant, bargain, sell, transfer, convey, assign and release to the Lessee all right, title and interest of the Lessor in and to the 338 railcars bearing the reporting marks and road numbers listed on Exhibit A hereto (together with any and all accessories, additions, and improvements from time to time incorporated or installed in any item thereof which are the property of the Lessor under the Lease (all such railcars and accessories being collectively, the "Equipment") "AS IS", "WHERE IS", AND WITH ALL FAULTS, and without recourse or any representation or warranty of any kind whatsoever, whether written, oral, express or implied (including, without limitation, without any representation or warranty as to the MERCHANTABILITY or FITNESS FOR A PARTICULAR PURPOSE of any item of Equipment), other than a warranty against Lessor's Liens (as defined in Appendix A to the Lease). Lessor also does hereby acknowledge that the Lease and the obligation of the Lessee to pay rent for the Equipment has terminated and that Lessor hereby releases and discharges any security interest it may have in the Equipment; provided, however, that Lessee is not released from any obligations under the Lease which by their terms survive termination of the Lease.


