

MEMORANDUM OF SCHEDULE NO. 8

TO LEASE AGREEMENT

BETWEEN

GREENBRIER LEASING COMPANY LLC (“LESSOR”)

EFFECTIVE: FEBRUARY 1, 2013

Memorandum of Schedule No. 8 dated as of FEBRUARY 14, 2013 and effective as of February 1, 2013, to a Lease Agreement made and entered into May 9, 2011 and effective October 1, 2010, by and between Greenbrier Leasing Company LLC, an Oregon limited liability company ("Lessor") and EOG Resources, Inc., a Delaware corporation ("Lessee").

WITNESSETH:






