**NOTICE OF
LEASE TERMINATION**

This Notice of Lease Termination dated as of April 8, 2013 by Flagship Rail Services, LLC (formerly known as AIG Rail Services, Inc.), a Delaware limited liability company, as successor lessor (the "Lessor").

WITNESSETH:

Lessor and Infineum USA L.P. (the "Lessee") were parties to that certain Car Leasing Agreement 2395-11, dated as of November 19, 1996, whereby Lessor agreed to lease to the Lessee and the Lessee agreed to lease from Lessor certain railroad cars pursuant to Rider No. 14, dated October 1, 2007 (as amended and assigned, the "Lease Agreement").

A Memorandum of Lease Agreement was filed with the Surface Transportation Board on December 18, 2007 at 10:30 a.m. under Recordation Number 27278, as assigned by that certain Memorandum of Assignment and Assumption Agreement filed with the Surface Transportation Board on January 4, 2008 at 2:00 p.m. under Recordation Number 27278-A and a notice of change of reporting marks and road numbers was filed with the Surface Transportation Board on January 21, 2010 at 8:00 a.m. under Recordation Number 27278-B.

Notice is hereby given that the Lease Agreement is terminated with respect to the railroad cars listed on Exhibit A hereto.

This Notice of Lease Termination shall not impair nor terminate any of the rights and obligations of the parties under the Lease Agreement which, by their terms, expressly survive its termination.


