FULL RELEASE OF SECURITY INTEREST

The undersigned, WILMINGTON TRUST COMPANY, as Secured Trustee under the Security Agreement-Trust Deed dated as of November 30, 1992, (the "Secured Party"), for good and valuable consideration, the receipt and sufficiency of which are acknowledged, does hereby terminate, release and discharge the security interest held by it which encumbers that certain railroad equipment identified in the Security Agreement (defined below).

Such security interest was granted pursuant to that certain Security Agreement-Trust Deed dated as of November 30, 1992, as thereafter supplemented, between the Secured Party and U.S. Bank National Association, not in its individual capacity, but solely as owner trustee (as successor-in-interest to The Connecticut National Bank) (collectively, the "Security Agreement"), which was originally recorded with the Interstate Commerce Commission on November 30, 1992 under Recordation Number 18015-A, with supplements thereafter recorded under Recordation Numbers 18015-C, -E, -G and -I.
