MEMORANDUM OF ASSIGNMENT AND ASSUMPTION AGREEMENT

This MEMORANDUM OF ASSIGNMENT AND ASSUMPTION AGREEMENT is dated as of April 30, 2013, by and between Trinity Industries Leasing Company, a Delaware corporation ("Assignor") and First Union Rail Corporation, a North Carolina corporation ("Assignee").

WITNESSETH:

1. Assignor, as lessor, entered into that certain Rider Eight (8) to Railroad Car Lease Agreement dated as of December 1, 2012 with NuStar Marketing, LLC, as lessee, incorporating the terms of that certain Railroad Car Lease Agreement dated as of August 26, 2009, as supplemented by that certain Rental Rate Adjustment Letter dated as of January 14, 2013 between Assignor and NuStar Marketing, LLC (the "Lease") for certain railcars described in Exhibit A attached hereto (the "Railcars").

2. Assignor and Assignee have entered into that certain Assignment and Assumption Agreement dated as of April 30, 2013, which is evidenced by this Memorandum of Assignment and Assumption Agreement with respect to the Lease and the Railcars.

3. This Memorandum of Assignment and Assumption Agreement may be executed in any number of counterparts, each of which shall be an original, all of which when taken together shall constitute one agreement binding on all parties, notwithstanding that all parties are not signatories to the same counterpart.


