NOTICE OF FULL TERMINATION OF LEASE



(successor to Ameritech Credit Corporation), as Lessor (the "Lessor"), for good and valuable consideration, the receipt and sufficiency of which are acknowledged, hereby gives notice that it has terminated the Master Lease Agreement, dated as of May 1, 1997, and Equipment Lease Schedule No. 1, dated as of May 1, 1997, as amended, modified or supplemented (the "Lease"), with CHICAGO FREIGHT CAR LEASING CO., as Lessee (the "Lessee").

A Memorandum of Equipment Lease, dated as of May 1, 1997, between Ameritech Credit Corporation ("Ameritech") and Lessee was duly filed and recorded with the Surface Transportation Board (the "Board") on May 2, 1997 under Recordation Number 20668. In addition thereto, a Memorandum of Bill of Sale and Assignment and Assumption of Lease Agreement between Ameritech and Lessor, dated as of July 2, 2010, was duly filed and recorded with the Board on July 2, 2010 under Recordation Number 20668-A. 
