

TERMINATION

This Termination, dated as of July 23, 2013, is by Relco Finance, Inc. ("Relco") (as assignee of The David J. Joseph Company ("DJJ"), successor by merger to Joseph Transportation Services, Inc. ("JTS")), as lessor, and Dana Corporation ("Dana"), as lessee.

WHEREAS, JTS and Dana Corporation ("Dana") entered that certain Lease dated as of August 11, 2000 (the "Lease") for one locomotive numbered JTPX 1205, as evidenced by a Memorandum of Railroad Equipment Lease Agreement between JTS and Dana, which was recorded at the Surface Transportation Board on October 4, 2000 under Recordation No. 23143; and

WHEREAS, DJJ, as successor to JTS, as seller and assignor, and Relco entered (i) a Purchase and Sale Agreement dated as of June 3, 2004, whereby DJJ sold to Relco and Relco purchased from DJJ 68 locomotives, as evidenced by a Bill of Sale dated June 4, 2004, which was recorded with the Surface Transportation Board (the "Board") under Recordation No. 24977 on June 22, 2004; and (ii) an Assignment and Assumption Agreement dated as of June 3, 2004, whereby DJJ assigned certain leases of the locomotives to Relco and Relco assumed the leases of the locomotives from DJJ, as evidenced by a Memorandum of Assignment and Assumption Agreement dated as of June 3, 2004, which was recorded with the Board under Recordation No. 24977-A on June 22, 2004; and

WHEREAS, the duties and obligations of the parties to the Lease have been satisfied and discharged.

NOW, THEREFORE, in consideration of the promises and covenants in the documents set forth above by reference, and for other valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Relco hereby terminates and cancels the Lease as of the date herein first written above; provided that this termination does not apply to provisions of the Lease stated to survive such termination.
