

MEMORANDUM OF LEASE TERMINATION (NOVA II), dated as of July 24, 2013, by and between NOVA CHEMICALS INC. ("Lessee") and U.S. BANK NATIONAL ASSOCIATION (as successor in interest to State Street Bank and Trust Company of Connecticut, National Association), not in its individual capacity, but solely as trustee ("Owner Trustee") under the Trust Agreement dated as of December 11, 2000, between FNBC Leasing Corporation and U.S. Bank National Association (as successor in interest to State Street Bank and Trust Company of Connecticut, National Association) (the "Trust Agreement"), and together with Lessee, the "Parties"). Capitalized terms used herein which are not defined herein shall have their respective meanings ascribed thereto as set forth in the Lease (as defined below).

WHEREAS, Owner Trustee, as lessor, and Lessee, as lessee, entered into that certain Equipment Lease Agreement, dated as of December 11, 2000, as supplemented by that certain Lease Supplement, dated as of December 11, 2000 (as supplemented thereby and as further supplemented from time to time, the "Lease"), a Memoranda of which was recorded with the Surface Transportation Board ("STB") on December 14, 2000 under Recordation Number 23253 covering the Leased Equipment (as defined in the Lease) described therein;

WHEREAS, effective as of the date hereof, the Lease is terminated with respect to the railroad equipment described in Schedule A hereto (the "Terminated Units"); and


WHEREAS, the Parties wish to show for the public record the existence of the aforesaid Lease termination with respect to the Terminated Units, and the respective interests therein of the Parties.

NOW, THEREFORE, to accomplish the foregoing, the Parties are filing this Memorandum of Lease Termination with the STB pursuant to 49 USC Section 11301(a) and with the Registrar General of Canada pursuant to Section 105 of the Canada Transportation Act.

This Memorandum may be executed in any number of counterparts, each executed counterpart constituting an original but all together only one such memorandum.


