

MEMORANDUM OF ASSIGNMENT OF SUBLEASES

THIS MEMORANDUM OF ASSIGNMENT OF SUBLEASES is made and entered into as of July ~~26~~ 2013, by and between BB&T EQUIPMENT FINANCE CORPORATION (the "Assignee") and BANC OF AMERICA LEASING & CAPITAL, LLC (the "Assignor"), with reference to the following:

Assignor, as Lessor, and American Railcar Leasing LLC, as Lessee, have heretofore executed that certain Rail Equipment Net Leasing Agreement dated as of June 30, 2010, and, pursuant thereto, that certain Schedule No. 002 dated June 30, 2010 (collectively, the "Lease"), pertaining to the railcars described therein and further described on Exhibit No. 1 attached hereto (the "Railcars").

Assignor and Lessee additionally entered into that certain Subleasing Consent and Assignment dated as of June 30, 2010 (the "Subleasing Consent") pursuant to which Lessee pledged, transferred and assigned to Assignor a first priority security interest in any and all subleases related to the Railcars (the "Subleases").

Assignor filed a Memorandum of Assignment of Subleases with the STB on June 30, 2010 under Recordation Number 29331-B to record Assignor's rights and interest in 181 railcars (a portion of which includes the Railcars) and Subleases pursuant to the Lease and Subleasing Consent.

Assignor, as assignor, and Assignee, as assignee, have executed that certain Assignment and Specification of Assigned Lease Schedule dated as of the date hereof to that certain Master Assignment Agreement dated as of April 29, 2008 by and between Assignor and Assignee, pursuant to which Assignor has assigned to Assignee all of its rights and obligations under the Lease and Subleasing Consent, but solely with respect to the Railcars and those particular Subleases related thereto.


The parties hereto wish to show for public record this Memorandum of Assignment of Subleases to provide notice of such assignment.


