

TERMINATION OF LEASE

This Termination of Lease is made and entered into as of FEBRUARY 7<sup>TH</sup> 2013, by and between Belvidere & Lehigh River Railway Company, Inc., P.O. Box 22, Ringoes, New Jersey (hereafter "BLHR") and Fortaleza Construction Company, Inc., P.O. Box 221, Salisbury, MD 21803 (hereafter "FCC").

WHEREAS, BLHR and FCC entered into a Standard Locomotive Lease Agreement dated August 31, 2011 (the "Lease"), under which FCC leased to BLHR one EMD SWSM 900 horsepower locomotive, b'n 14027, built August 1951, currently marked BVDR 908 (formerly marked MDDE 802) (the "Locomotive"); and

WHEREAS, BLHR is exercising its right under the Lease to purchase the Locomotive, and in connection therewith the parties desire to terminate the Lease;

NOW THEREFORE, intending to be legally bound, the parties hereto agree as follows:

1. The Lease is hereby terminated and shall be of no further force and effect.
2. All terms of the Lease have been satisfied, and each party agrees it has no claims against the other party under or related to the Lease, or to the Locomotive or its use.
