This Notice of Termination of Bareboat Charter and Termination of Memorandum of Bareboat Charter dated as of December 31, 2012 is made by Marquette Vessel Statutory Trust ("Owner"), and pertains to that certain Master Bareboat Charter Agreement, and to Schedule 004 thereto, each dated December 26, 2008 (collectively, as amended, the "Bareboat Charter") between Owner and Marquette Transportation Company Gulf-Inland, LLC ("Charterer").

WITNESSETH.

WHEREAS, Owner and Charterer entered into the Bareboat Charter whereby Owner agreed to charter to Charterer the U.S. documented towing vessel BLESSED TRINITY, Official Number 1216547 (the "Vessel"); and

WHEREAS, Owner and Charterer entered into that certain Memorandum of Bareboat Charter dated December 29, 2008 evidencing such charter of the Vessel which was recorded with the Surface Transportation Board on January 6, 2009 at 11 44 a m under Watercraft Recordation No W-100, and

WHEREAS, the Bareboat Charter between Owner and Charterer with respect to the Vessel has been terminated

NOW, THEREFORE, the Owner desires to clarify the public record state as follows.

1 This Notice serves as notice that the Bareboat Charter between Owner and Charterer relating to the Vessel and evidenced by the Memorandum of Bareboat Charter filed with the Surface Transportation Board has been terminated in all respects


