MEMORANDUM OF DEMISE CHARTER PARTY TERMINATION**

This Notice of Termination of Demise Charter Party and Memorandum of Demise Charter Party Termination dated as of February 7, 2014 is made by Wells Fargo Bank Northwest, National Association, as owner trustee ("Owner"), and pertains to that certain Demise Charter Party dated November 26, 2003 ("Demise Charter") between Owner and Rhodia Inc. (now Solvay USA Inc.) ("Charterer").

**WITNESSETH:**

**WHEREAS**, Owner and Charterer entered into the Demise Charter whereby Owner agreed to charter to Charterer the non-documented tank barge vessels RHA 2201, Hull No. 9528, **RHA 2202, Hull No. 9529** and RHA 2203, Hull No. 9530 (collectively, the "Vessels"); and

**WHEREAS**, Owner and Charterer entered into that certain Memorandum of Demise Charter Party dated November 26, 2003 evidencing such charter of the Vessels which was recorded with the Surface Transportation Board on December 5, 2003 at 1:45 p.m. under Watercraft Recordation No. W-71; and

**WHEREAS**, the Demise Charter between Owner and Charterer with respect to the Vessels has been terminated.

**NOW, THEREFORE**, the Owner desires to clarify the public record state as follows:

1. This Notice serves as notice that the Demise Charter between owner and Charterer relating to the Vessels and evidenced by the Memorandum of Demise Charter filed with the Surface Transportation Board has been terminated in all respects.

2. Owner wishes to record this Notice of Termination of Demise Charter Party and Memorandum of Demise Charter Party Termination so as to release the lien with respect to the Vessels.


