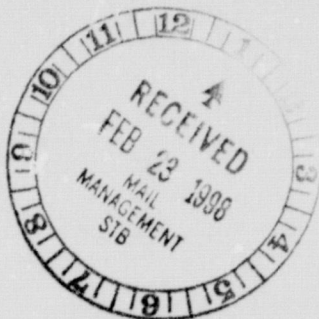
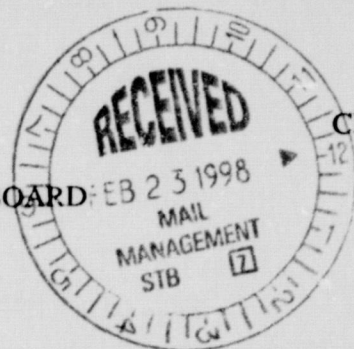

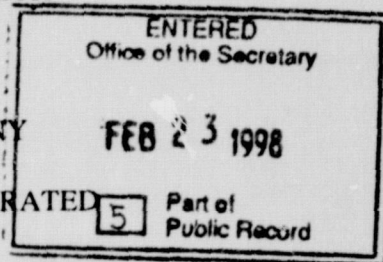

NOTICE OF WITHDRAWAL OF RESPONSIVE APPLICATION


Canadian National Railway Company ("CN"), Grand Trunk Corporation ("GTC") and Grand Trunk Western Railroad Incorporated ("GTW")¹ hereby withdraw their Responsive Application seeking trackage rights, which was filed in Finance Docket No. 33388 (Sub-No. 81), and their related Verified Notice of Exemption, which was filed in Finance Docket No. 33388 (Sub-No. 83).

¹ CN as used herein will embrace CN's wholly-owned subsidiary GTC, and GTC's wholly-owned subsidiary GTW.

CN's Responsive Application sought certain limited trackage rights to provide balanced competition for traffic moving to Detroit Edison's Trenton Channel Power Plant at Trenton, MI. The related Notice of Exemption sought authority to construct and operate a short connecting track needed to implement the proposed trackage rights. Detroit Edison, the affected shipper, filed a statement in support of CN's Responsive Application.

Detroit Edison, pursuant to recent discussions it has had with CSX, has advised CN that Detroit Edison's interests now would best be served by withdrawal of CN's request for trackage rights. Accordingly, CN hereby withdraws its Responsive Application and Verified Notice of Exemption.²


