Wednesday, March 15, 2023

- 1. RSTAC Chairman Mark Wegner at the STB Headquarters called the meeting to order at approximately 1:15 pm EDT.
- 2. RSTAC Members provided the first round of field reports to STB Board Members and staff.
- 3. At 2 pm, Mr. John Jensen, Union Pacific's Director of Crew Management, appeared to present to the STB and the RSTAC the current state of affairs with respect to quality-of-life initiatives that Union Pacific is pursuing, including a pilot program in a Kansas crew district, with promising results.
- 4. At 3 pm, Mr. Jeremy Ferguson, President of SMART Transportation Division, presented to the STB and the RSTAC an overview of how his organization represented railroad workers during negotiations leading up to the recent labor settlement. He also discussed continued railroad labor concerns.
- 5. Field reports continued following Mr. Ferguson's presentation.
- 6. The first day of meetings was adjourned at approximately 5:15 pm.

Thursday, March 16, 2023

- 1. The RSTAC members and STB Board members reconvened at 9 am. Discussion regarding selection of RSTAC leadership for 2023-2024 was deferred until the June 2023 RSTAC meeting.
- 2. Field reports continued.
- 3. At 10 am, a discussion ensued regarding an RSTAC whitepaper, "RSTAC Recommendation to the Surface Transportation Board to Examine the Nation's Rail Boxcar Supply." After an hour of discussion, the voting RSTAC members voted unanimously to request an STB reopening of Docket Ex Parte No. 334 (Railroad Car Hire Compensation) for public comment. (Ben Abrams called into the RSTAC for this portion of the meeting.) The RSTAC voted to submit the whitepaper for the Board's review and consideration.
- 4. A discussion was had regarding the dates of the spring RSTAC meeting, landing on June 20 and 21.
- 5. The second day's meetings were adjourned at approximately 1 pm.
