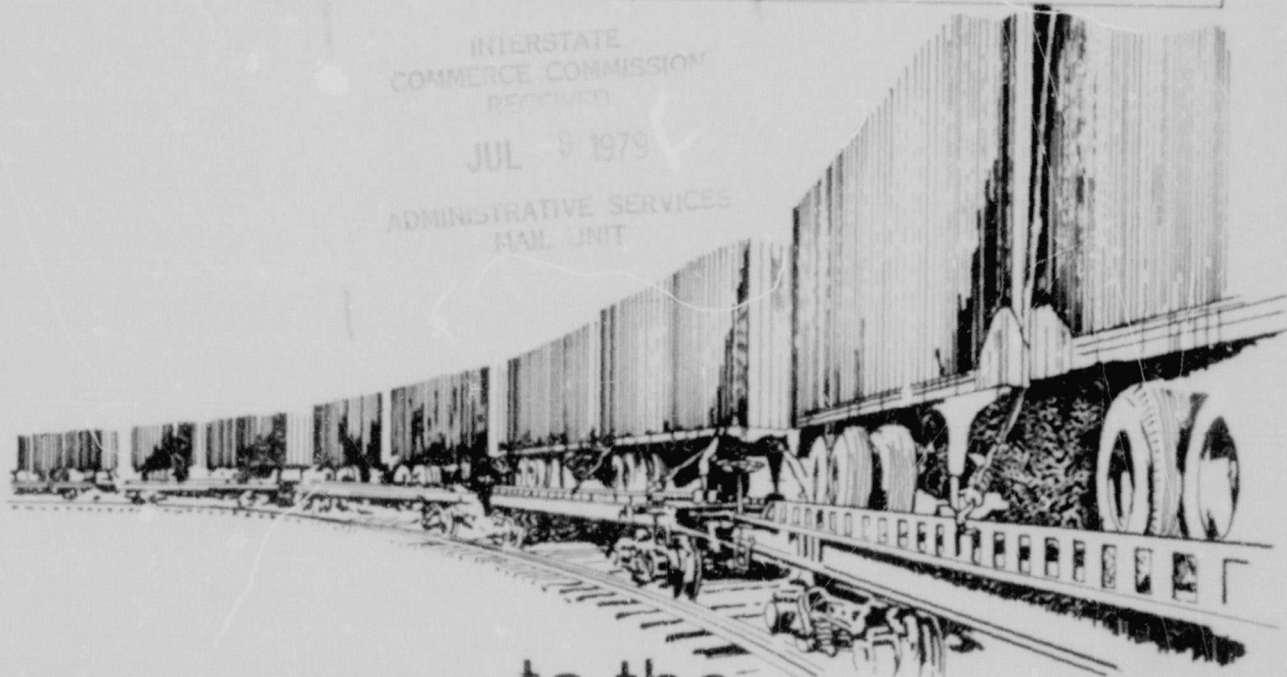

In 1911 the branch line from Washburn, Me. to Sweden was built and the line from Carson, Me., to Caribou, Me. was built in 1914. Finance was arranged through stock and bond issues, and bonds were redeemed completely in 1952. In 1977 the Interstate Commission authorized abandonment of the Sweden branch, and effective March 14, 1977 the line from Carson to Sweden was officially abandoned under Certificate of Abandonment bearing Docket No. AB-42, "Sub No. 2." Service date March 4, 1977.
