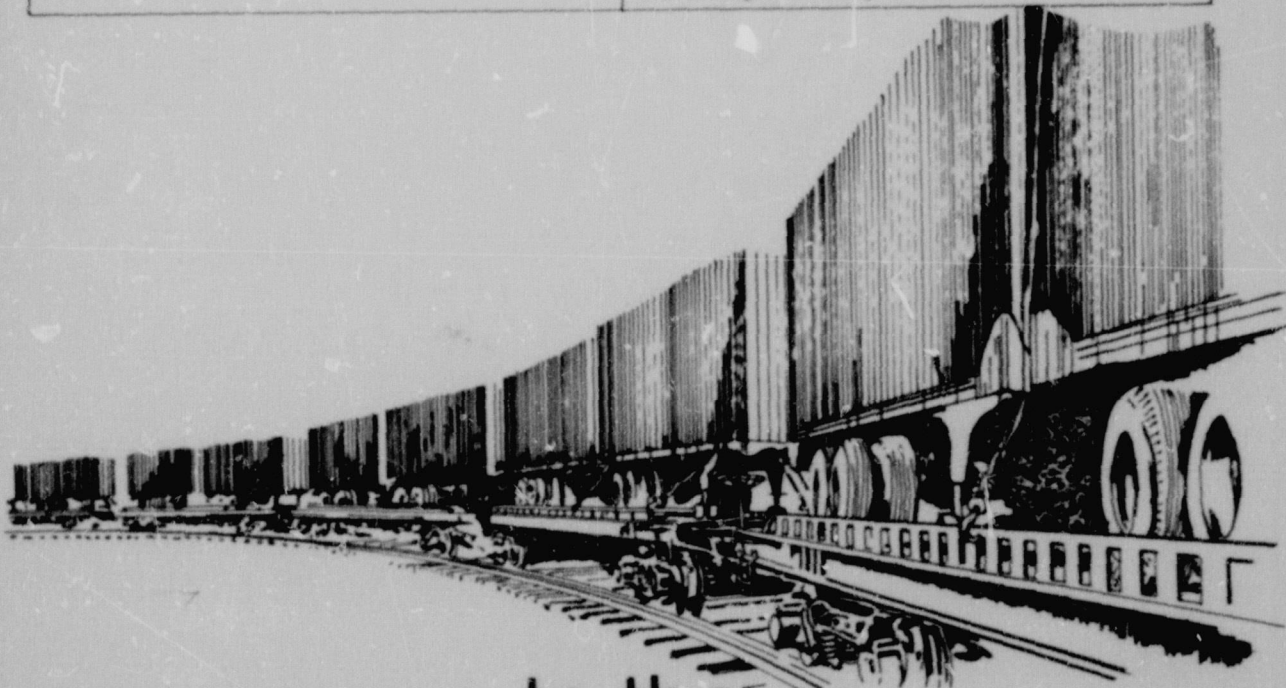

* Annual actuarial valuations produce separate monthly per capita accrual rates for the hourly and salaried employees of Bauxite & Northern Railway Company. Each monthly per capita accrual rate is based on employee statistics and the benefits provisions as of the valuation date and includes components for current and past service costs. Actual contributions for the year are determined by applying the monthly per capita accrual rate to the number of employees each month who are actively at work or on layoff but still subject to recall. This procedure is consistent with the prior year's procedure.

** Bauxite & Northern Railway Company participates in Employees' Retirement Plans of Aluminum Company of America, Plan I (salaried) and Plan II (hourly), which cover most of the employees of Alcoa and several of its wholly-owned subsidiaries. The amount of unfunded vested benefits attributable to Bauxite & Northern Railway Company has not been separately calculated.

*** Plan I includes Aluminum Company of America and 21 of its wholly-owned subsidiaries; Plan II includes Aluminum Company of America and 13 of its wholly-owned subsidiaries. Annual actuarial valuations of the plans assign a monthly per capita accrual rate to each participating company based on its employee statistics and the applicable benefit provisions as of the valuation dated.
