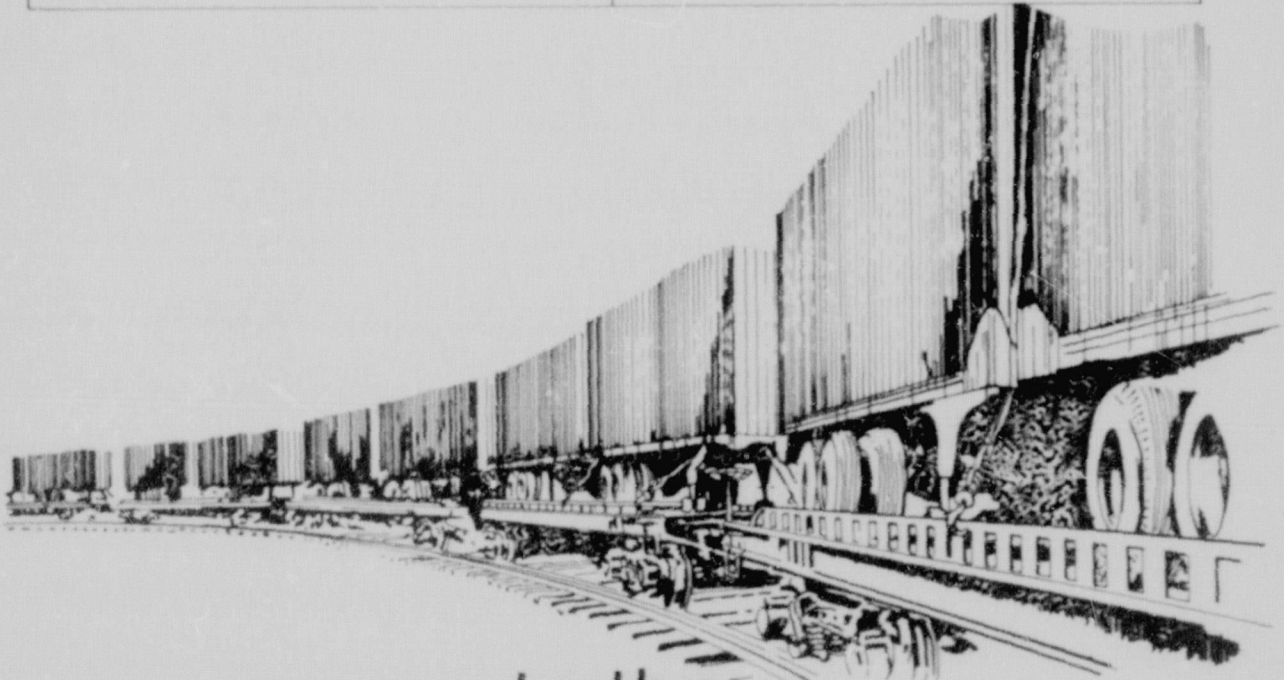

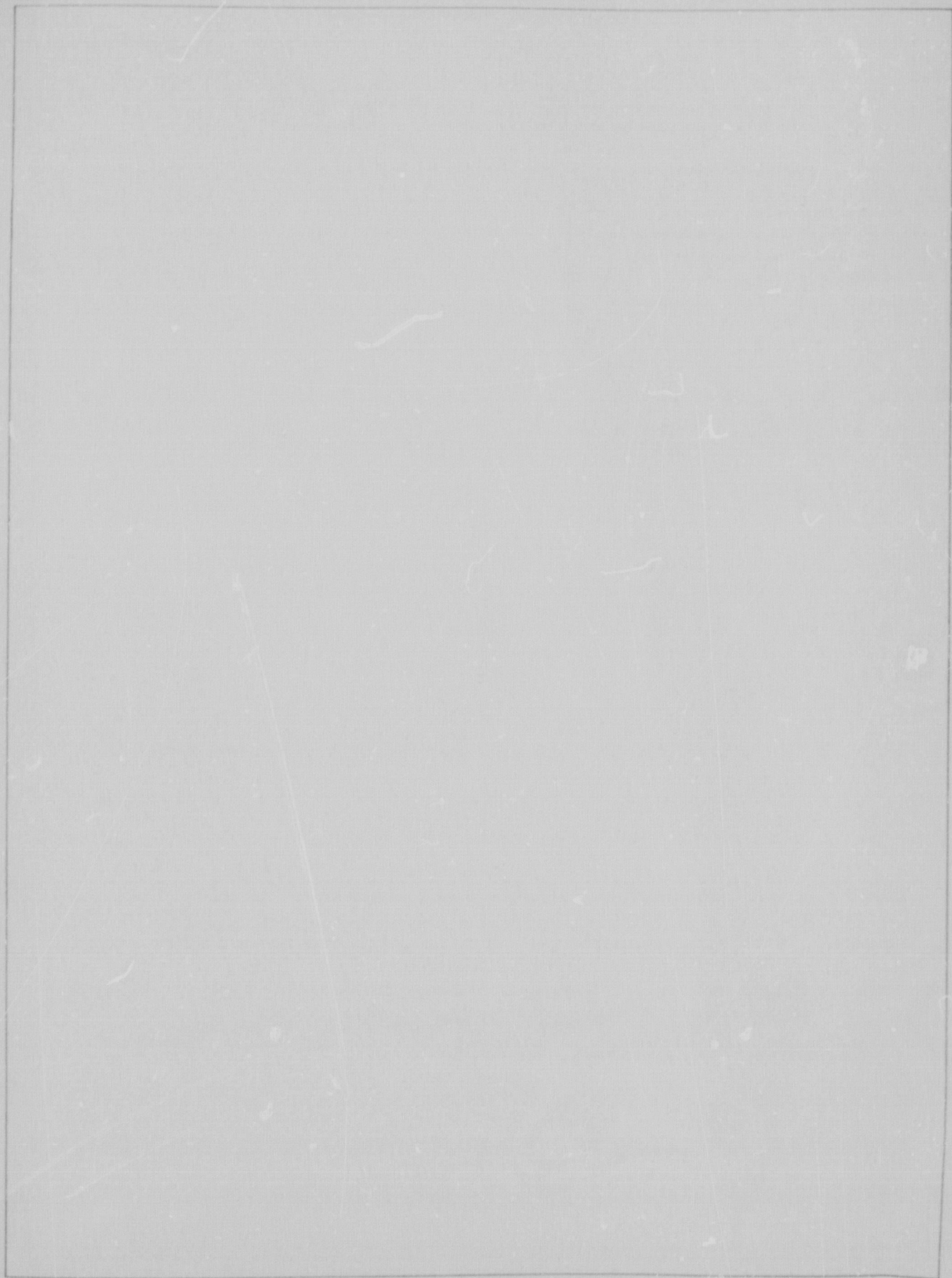

546. The company emerged from reorganization in 1978 with all creditors but two paid in full. Those two were issued a total of 17,532 shares of a new preferred stock (par value = \$1), and with the exception of this new stock, the pre-reorganization corporate structure remains intact.
