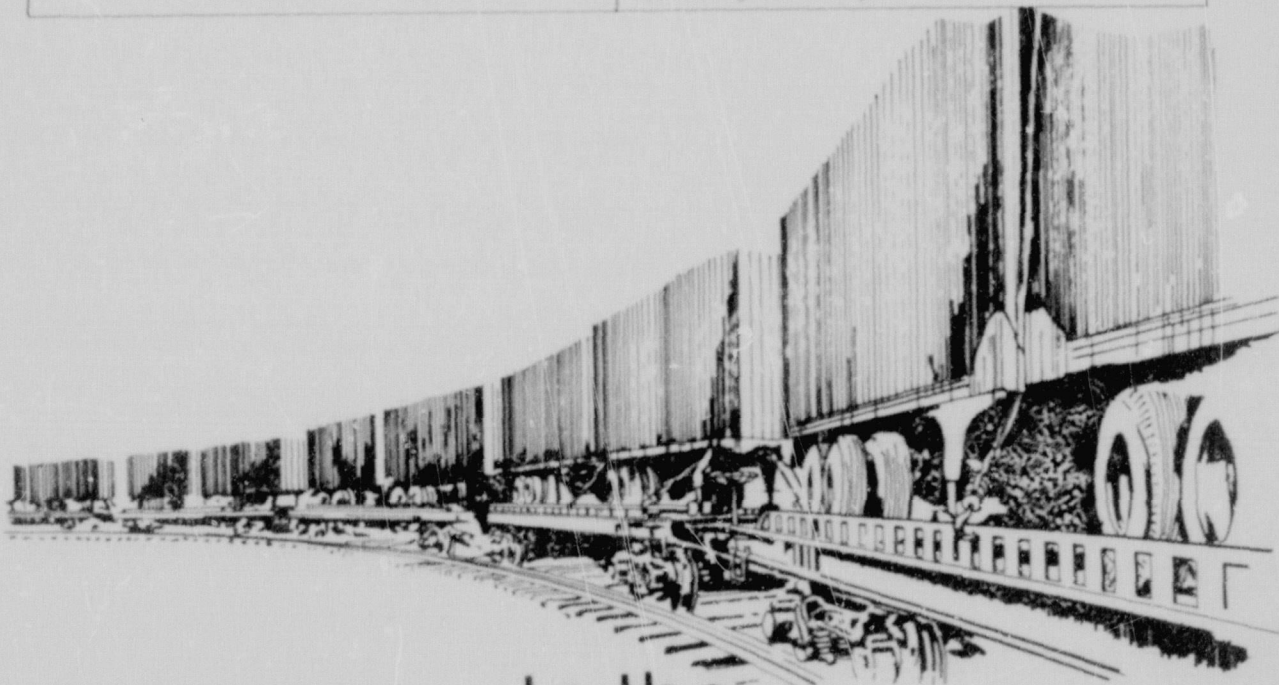

In February, 1966, Dolly Madison Industries, Huntingburg, Indiana, purchased all stock of the Ferdinand Railroad Company. The Ferdinand Railroad Company is a separate entity of Dolly Madison Industries.
