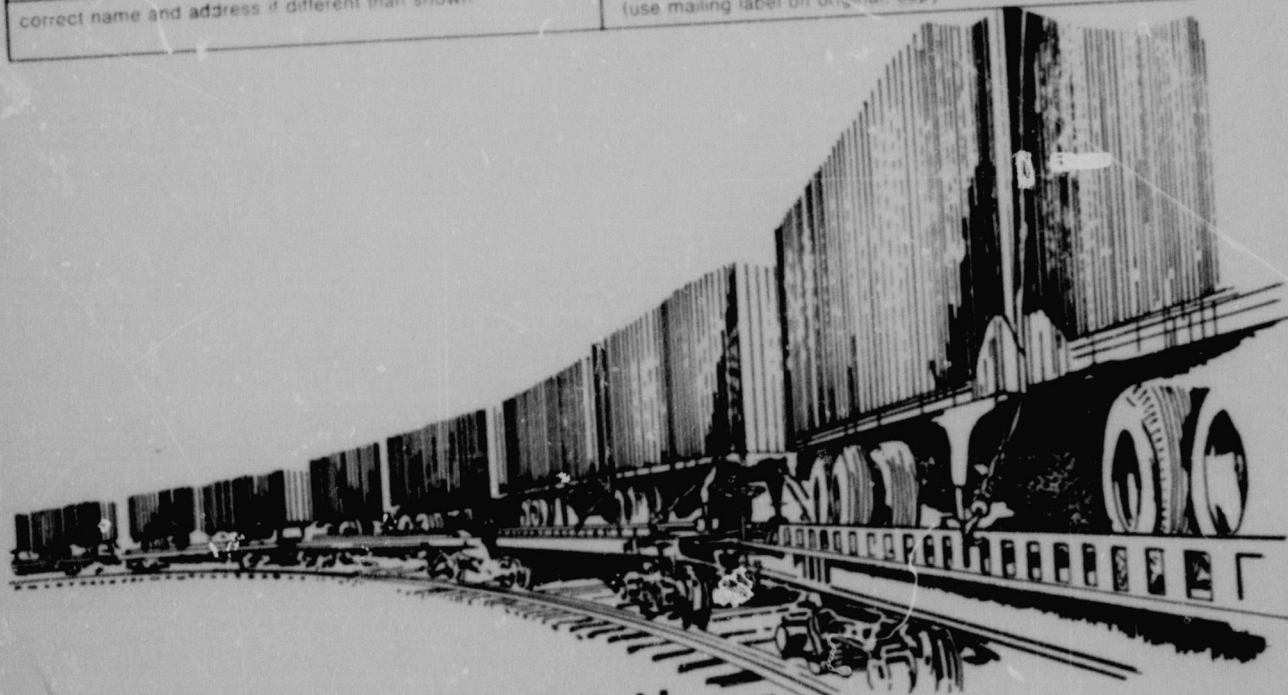

Finance Docket No. 21181. The stock owned by Texas and Pacific Railway was transferred to Missouri Pacific Railroad Company in November 1976.

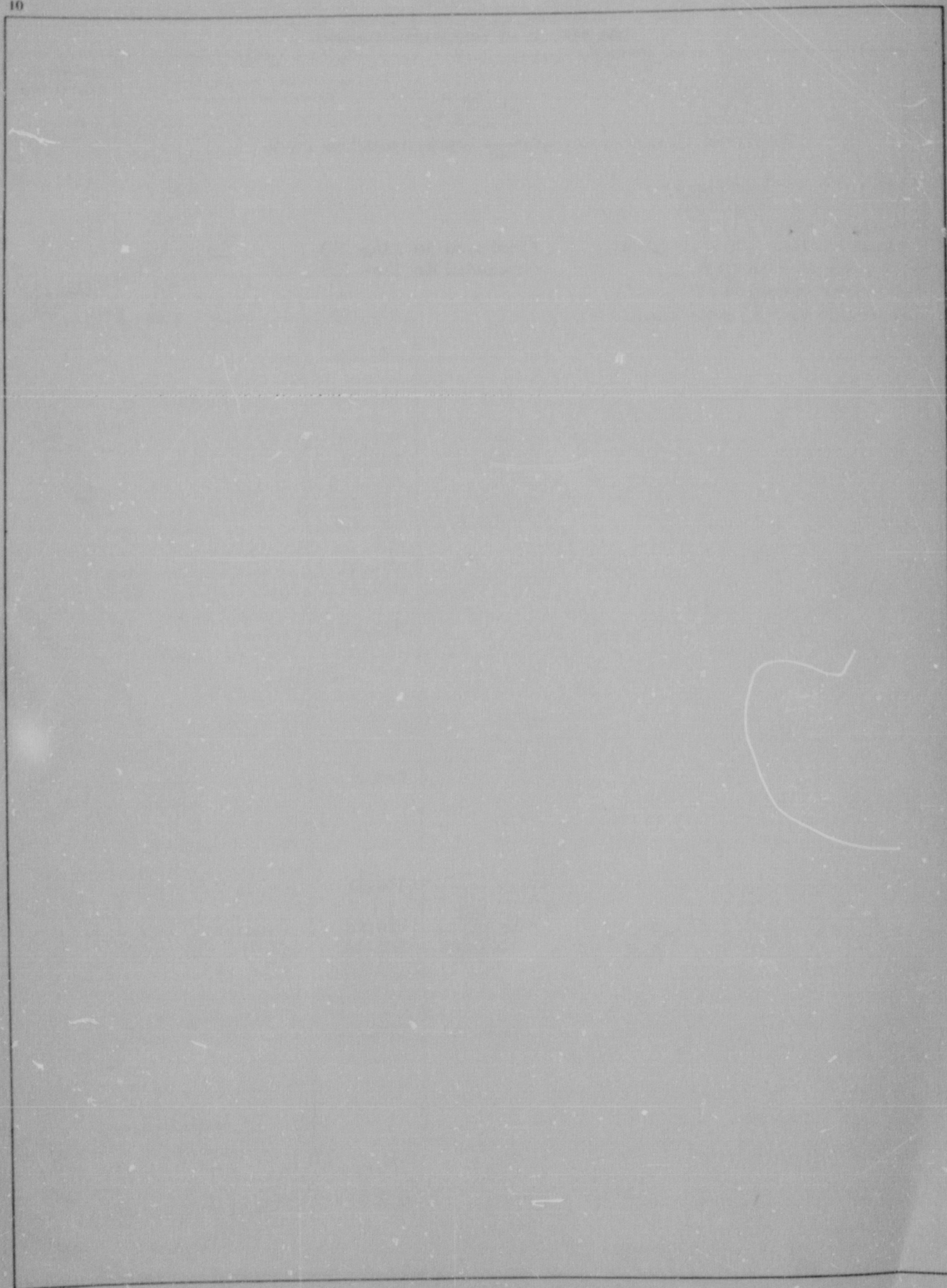
