Lease provides that the lessees shall maintain the property and pay the cost of maintaining the corporate existence and organization of the Lessor. All of the working Assets and Liabilities were taken over by the Lessees. The income and expenses arising from the property and its operation were included in the accounts of Reading Co. and Lehigh Valley Railroad.
