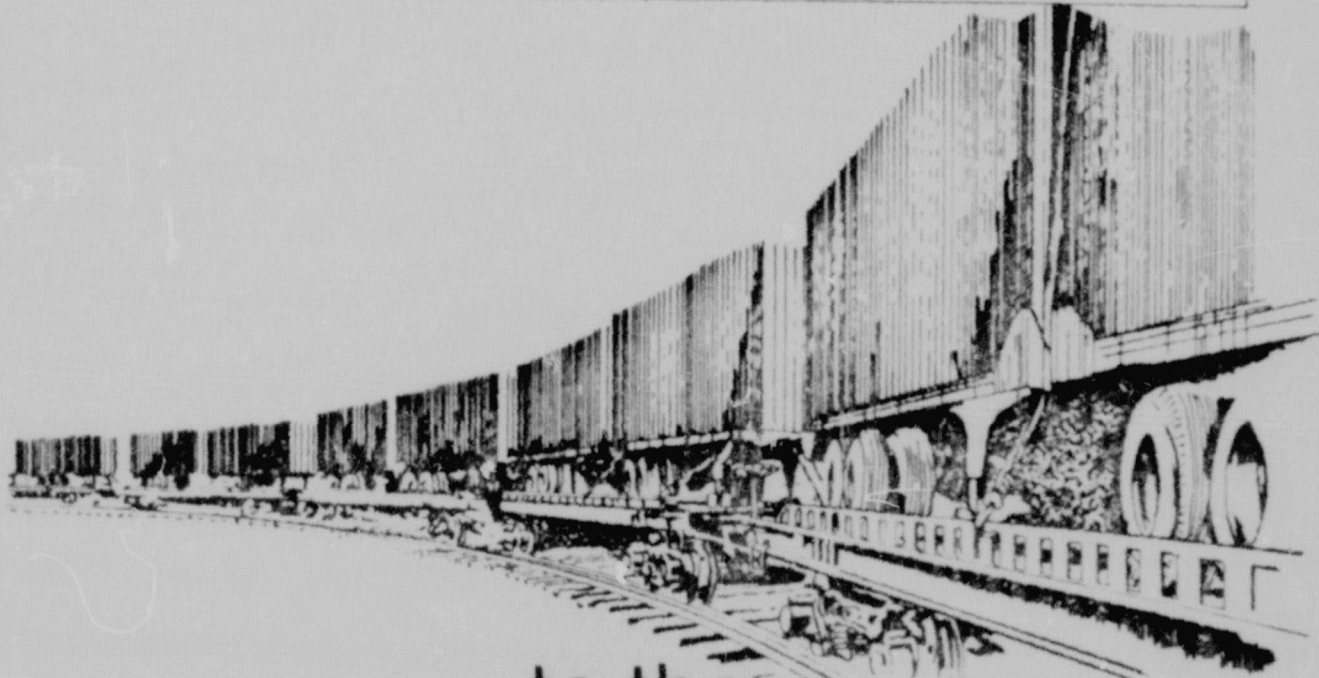

The Lackawaxen and Stourbridge Railroad Corporation is a wholly owned subsidiary of the Delaware Otsego Corporation.

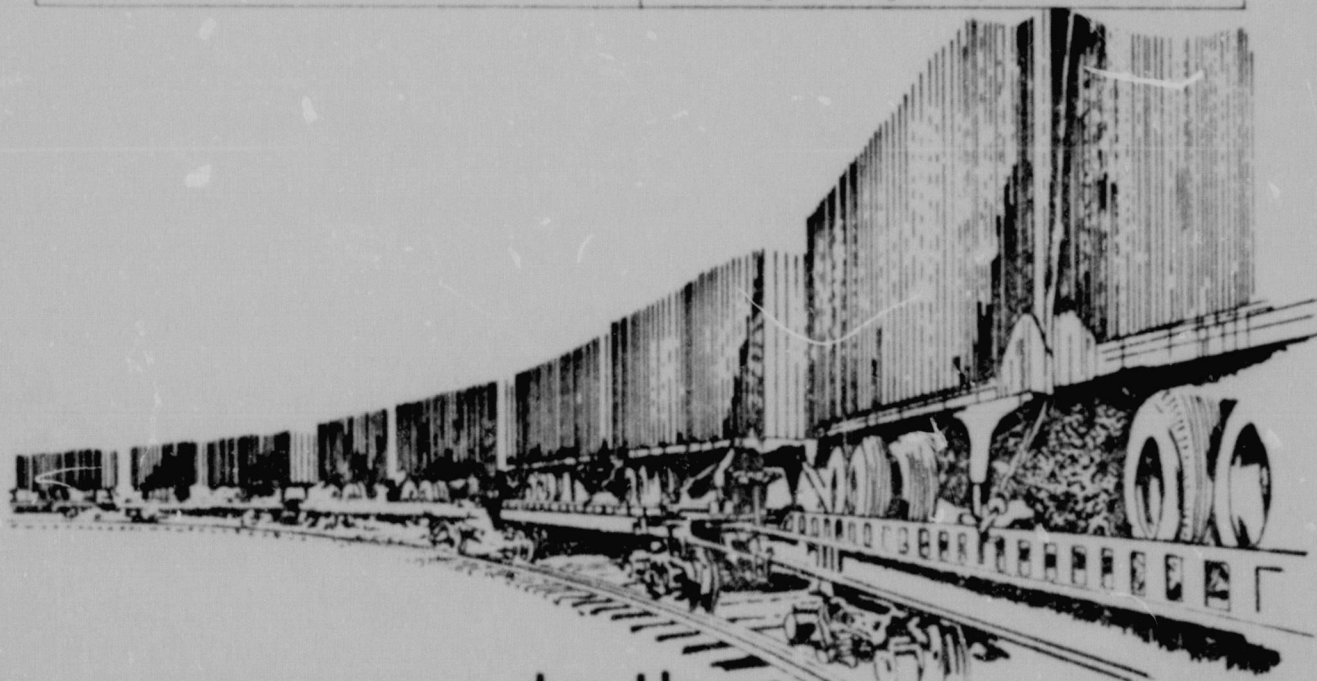
