Cloud River Consulting actuaries in San Francisco, Calif. last service liability was paid on formation of plan. Plan has been changed to operating expense account 457 since the first 1961. 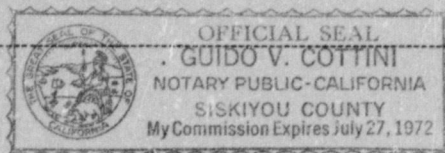

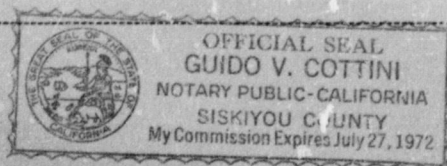
