NOTE 2: All track and right-of-way are owned by the State of New Hampshire. Equipment consists of one locomotive, a G.E. 44 Ton, owned by the State of New Hampshire and one locomotive, Alco 100 Ton, owned by the North Stratford Equipment Corporation, both of which are leased. Also there is one ballast regulator leased from the North Stratford Equipment Corporation. The North Stratford Railroad Corporation has taken no depreciation.
