This action was due, in part, to Del Monte Corporation notifying Mr. Riddle, President, in a letter dated December 23, 1971 that it would no longer be utilizing the services of the railroad operated by Oahu Railway, Inc. At that time, Del Monte Corporation was the only customer-user of the railroad after Dole Company, another major user ceased said usage of the railroad early in 1971. Inasmuch as the railroad is now without any customer-user, the Company has abandoned the railroad and ceased its operation effective December 31, 1971. Consequently, all railroad assets were sold during 1972 and the Company dissolved on July 31, 1972.
