

There is submitted herewith the Annual Report of Stockyards Service Company for the fiscal year ended October 31, 1971.

The number of cars of livestock handled was 1,520 compared to 2,103 for the year 1970, or a decrease of 583 cars.

The number of decks of livestock shipped and received determines our earnings and gross revenue for 1971 amounted to \$17,608.80 compared to \$22,683.85 for a decrease of \$5,075.05.

Expenses were \$15,416.37 compared to \$15,985.77 or a decrease of \$569.40.

There was a net gain from operations of \$1,507.98 compared to \$4,698.08 for the year 1970.
