The respondent was organized to develop traffic from timber, agriculture and other resources in Sumter and Choctaw Counties, Alabama.

The road now extends from Lilita, Alabama, its junction with the Southern Railway System, in a southerly direction 3.55 miles to a point 0.78 miles south of Bellamy, Alabama. During 1958, 18.67 miles of main line extending southward from that point to Choctaw City, Alabama, a junction point with Meridian & Bigbee Railroad Company, were abandoned and dismantled pursuant to authority granted in Finance Docket 20008.

There have been no consolidations, mergers, re-organizations or bonding.
