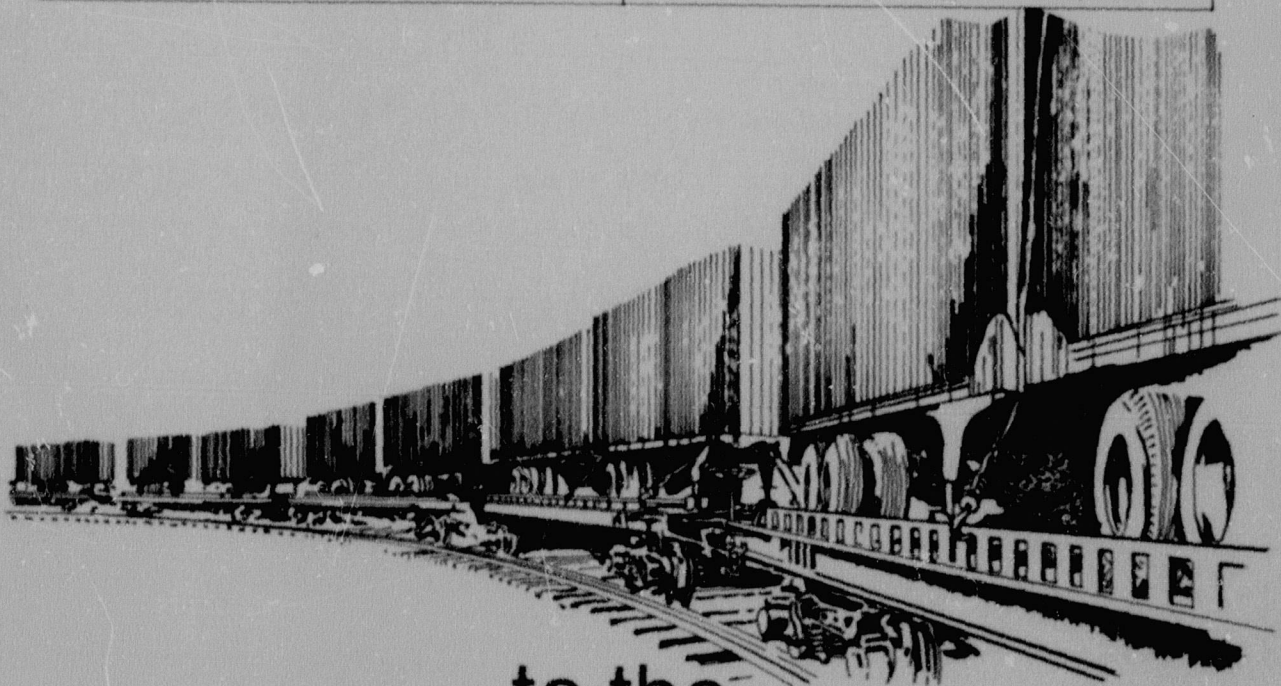

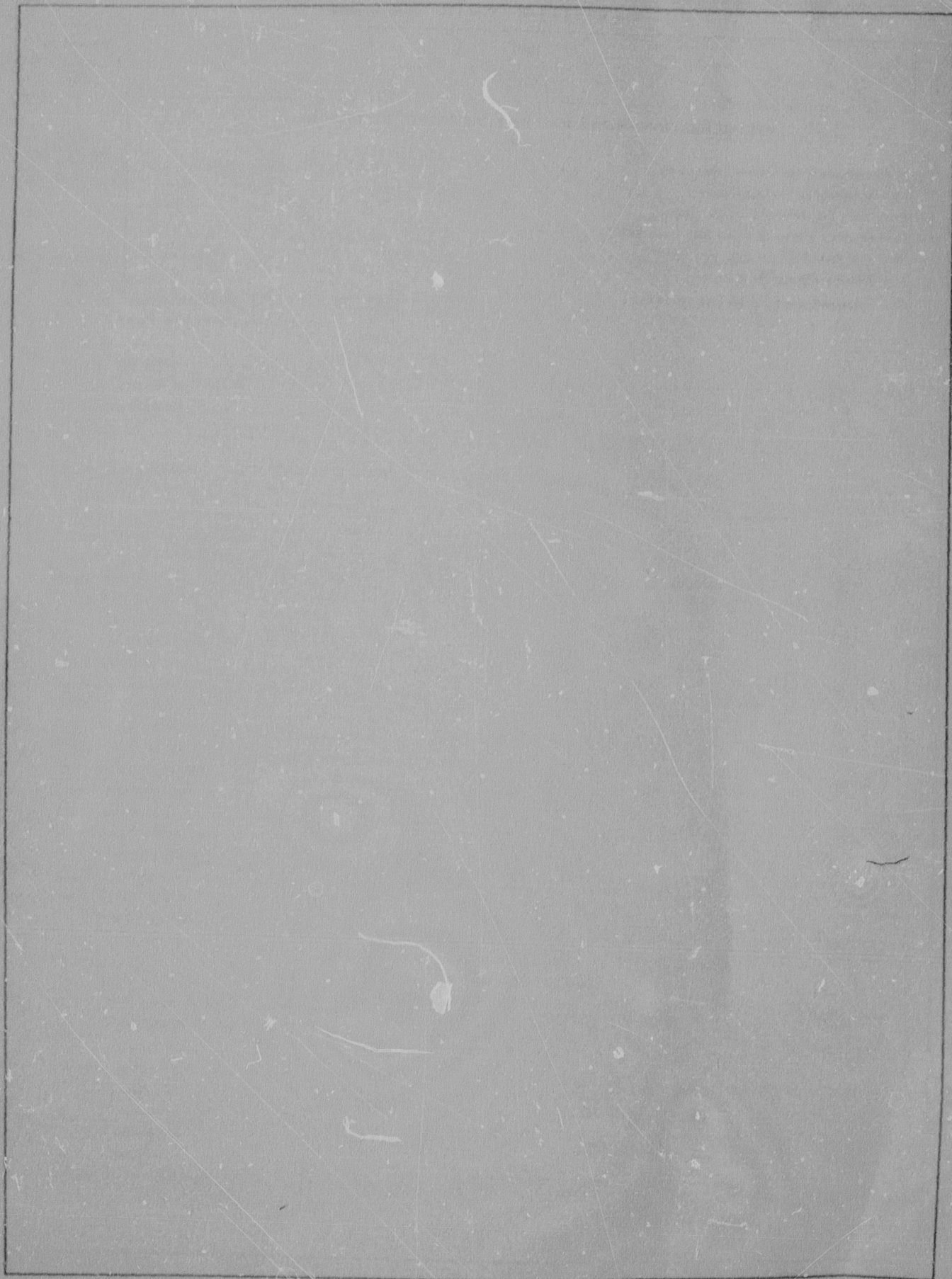

7. On June 13, 1978, respondent executed a long term note with Manufacturers Hanover Trust Company to finance the construction of a new dock (Dock 41) for the receipt of imported crude oil. Three local industries, by the terms of an executed agreement with respondent, are joint users of the dock and guarantee full payment. This note, in the amount of \$4,276,775.37 is to be repaid in 90 months with a maturity date of December 3, 1988. During the first 48 months the interest is computed at 3/4% above the Bank's prime rate per annum and in the final 42 months the interest is increased to 1% above the Bank's prime rate per annum. Through December 31, 1978, \$380,167.84 principal and \$286,585.67 interest had been paid to the Bank.
