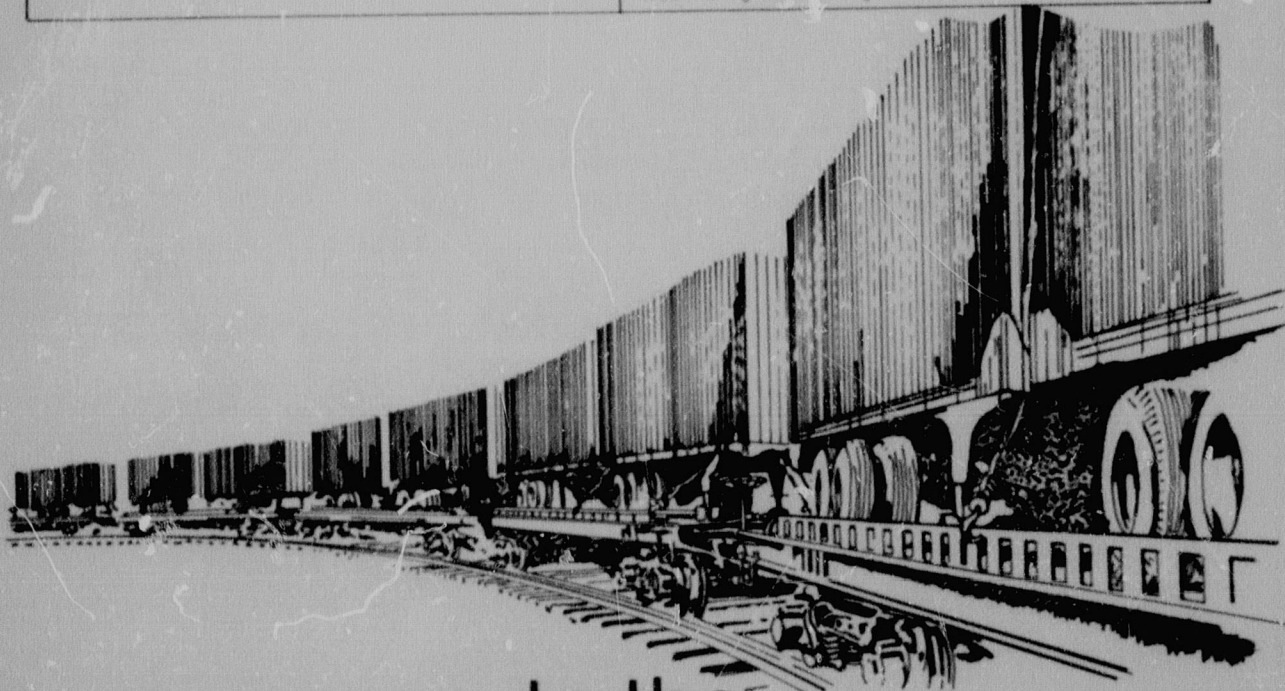

ITEM 3 The River Terminal Railway has no procedures to account for pension funds or recording current and past service costs. This is consistent with prior years.

The River Terminal Railway Company participates as a qualified subsidiary in the pension plans of Republic Steel Corporation. The plan covers eligible hourly paid employees and eligible salaried personnel. Republic Steel Corp. administers the plan.

The River Terminal Railway Company makes contributions to the plans annually. The total contribution authorized and paid into the pension trust fund for the year 1978 amounted to \$761,500. The amounts are based upon actuarial computations as related to the company's experience and circumstances, and in accordance with the terms set up in the plans.

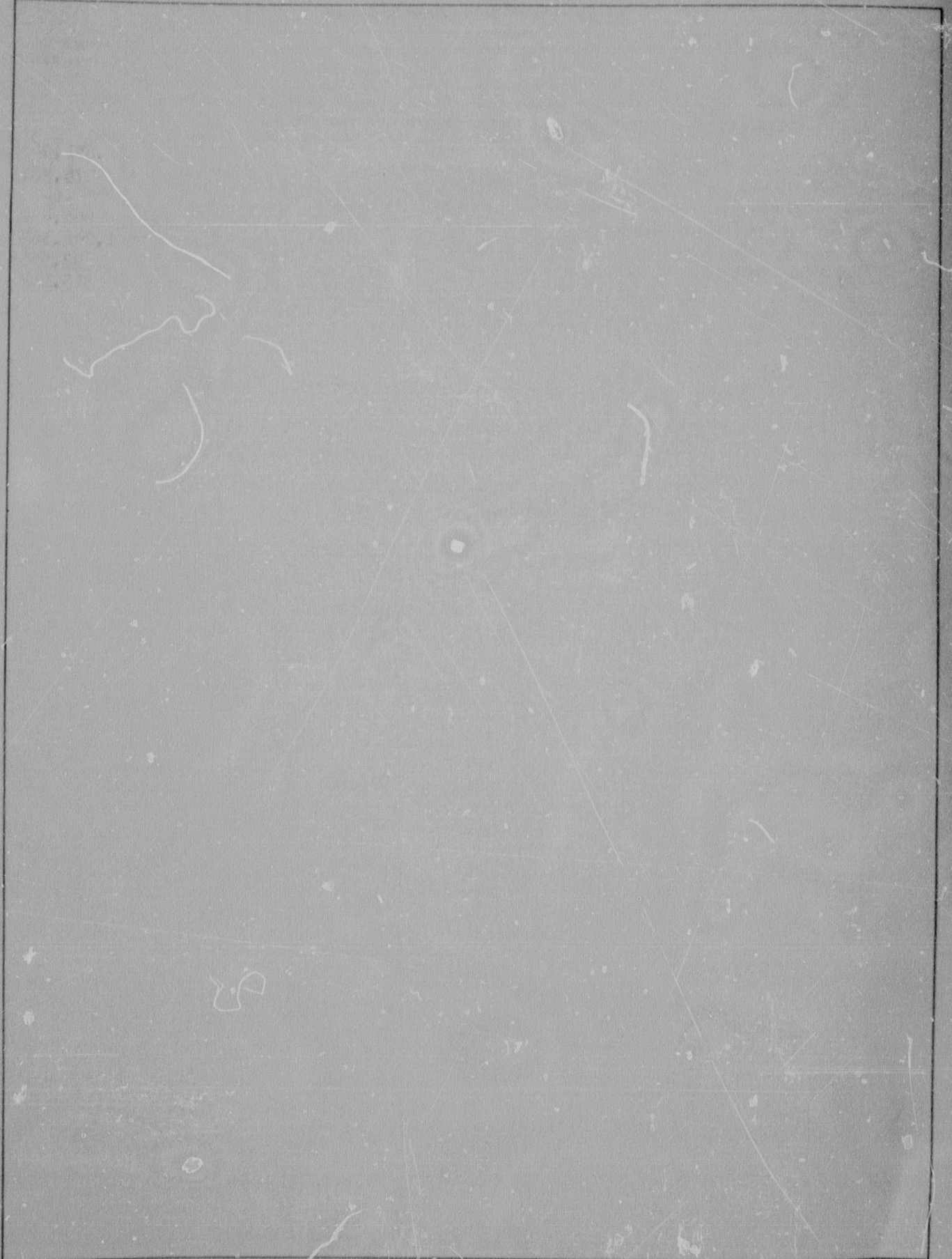
