NOTES TO UNAUDITED FINANCIAL STATEMENTSDecember 31, 1972

1. A summary of the significant accounting policies followed by this Corporation in the preparation of the accompanying unaudited financial statements is set forth below:

Properties - Track structure is accounted for by use of the replacement method. Under this method no deduction for depreciation is calculated and no accumulated depreciation is maintained. The original cost of the track account was capitalized. When any of the track structure is replaced in kind and quality, the asset account is not changed and the replacement costs are expensed. When any of the track structure is replaced with a betterment, the cost of the betterment is capitalized. Costs of additions and major improvements of depreciable properties other than track structure are capitalized, and maintenance and repairs are charged to expense as incurred. Depreciation expense totaling \$4,042.81 for the year on properties not accounted for under the replacement method is computed on the straight-line method over the Interstate Commerce Commission life guidelines.

Investment Tax Credits - Credits are accounted for using the flow-through method which reduces Federal income tax expense for the year in which qualified property is placed in service.

2. As a result of the net operating loss for 1972, and the unused investment tax credit for 1971, the Corporation has filed applications for refunds of Federal income taxes. Also, for Federal income tax purposes, the Corporation has unused investment tax credits, in the amount of \$4,366.07, available as a carryover to future tax years.
