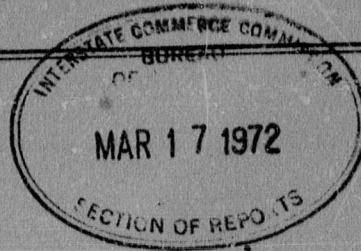

Incorporated March 11, 1922. Interstate Commerce Commission Finance Docket No. 4298 authorized the issuance of \$3,000 Capital Stock and \$800,000 First Mortgage Bonds October 15, 1924, and an additional sum of \$75,000 was also obtained from the tenant Companies, \$54,886 in 1925, and \$20,144 in 1926. On October 16, 1924, contract was entered into with the Northeastern Construction Company to build the station, do the grading, etc. The Company laid its own tracks. Work was begun in December 1924 and was completed and the station placed in service April 15, 1926.
