1. G4 Intermodal facility

Description and Purpose:

This project will create incremental capacity necessary to support projected domestic and international intermodal volume growth in the Chicago market and enable more efficient handling of existing traffic in Chicago.

Joliet, Will County, Illinois

First half of 2023

2. Geneva 3rd Main Track

Description and Purpose:

Construct 8 miles of third main line track which will create a 41 mile stretch of triple main line track on Union Pacific's Geneva Subdivision, which runs from Chicago to Clinton, Iowa. The project will enhance fluidity, improve premium service, and improve passenger on-time performance on the corridor.

Location:

Chicago area, Cook, DuPage, and Kane Counties, Illinois

Estimated completion date:

First quarter of 2025

Update:

Project continues as described.

3. **Houston Area Yard Improvements**

Description and Purpose:

This project includes expanding Englewood Yard and consolidating Englewood intermodal ramp operations into the intermodal ramp at Settegast Yard. Work at these facilities will create the incremental classification capacity necessary to support projected growth in Gulf Coast manifest traffic, improve the efficiency of intermodal operations, and enhance the fluidity of train movements through the greater Houston terminal complex.

Houston, Harris County, Texas

Estimated completion date:

Second half of 2023

Update:

Project continues as described.

4. **Inland Empire Intermodal Terminal**

Description and Purpose:

This project provides incremental intermodal lift capability, replaces manifest switching capacity, and enhances fluidity in and around the Inland Empire. This project includes multiple components, including the reconfiguration of the West Colton Hump Yard, repurposing a portion of the West Colton Manifest Receiving Yard for expansion of the Inland Empire Intermodal Terminal (IEIT), expansion of the Montclair Yard, and construction of 8 miles of second main track along Union Pacific's Alhambra Subdivision which runs from Los Angeles to Colton, California.

Estimated completion date:

Fourth quarter of 2025

Construction has been initiated.

5. Mesquite Intermodal Expansion

Description and Purpose:

This project will increase intermodal and automotive capacity necessary to support projected growth in the Dallas / Ft. Worth market. The project includes track and parking expansions for both co-located intermodal and automotive terminals.

Mesquite, Dallas County, Texas

Fourth quarter of 2024

Update:

Construction has been initiated.

6. Kansas City

Description and Purpose:

This project will create incremental capacity necessary to support projected domestic and international intermodal volume growth in the Kansas City market. Project will repurpose Armourdale Yard into an intermodal terminal with track reconfiguration and reconstruction, paving for parking, and construction of ancillary facilities to build a new intermodal terminal that will replace UP's current Neff intermodal terminal.

7. Lathrop
