Dear Representatives Shuster, DeFazio, Denham and Capuano,

I am writing to provide information pertaining to the Surface Transportation Board's implementation of Public Law 114-110, *Surface Transportation Board Reauthorization Act of 2015.* In addition to becoming reauthorized for the first time since the agency's inception 20 years ago, we are now fully independent with five seats on the Board and investigative authority. As you know, the passage of this reauthorization significantly impacts the functions of the agency and requires the reporting of certain information concerning our rate case processes, as well as open regulatory proceedings and formal and informal complaints. With this letter, please find a status chart of the major actions that the Board is undertaking to execute these requirements. I will send you monthly updates until all relevant provisions of the Reauthorization Act are completed.

I thank you for your thoughtful oversight and interest in the Board, and look forward to meeting with you in the near future to discuss the action items in this chart and answer any questions that you might have about this or any other matter before the Board.
