## I. Agenda

- After reviewing RSTAC practices with STB Chairman Roger Nober, members were again advised that
  meeting discussions are confidential, with any inquiries regarding RSTAC activities to be directed to the

- Elections for new officers were held. It was motioned and approved to support the offices of Chair -Sharon Clark; Vice Chair - Bob Bailey; and Secretary -Robert Pugh. An Executive Committee was also formed composed of the Chair, Vice Chair, Secretary, Past-Chair - Peter Gilbertson, Large Railroad - Stevan Bobb, and Public Interest Member - James Brunkenhoefer. These offices are to be held for one year, with elections for new officers to be held in first quarter 2004.

## II. Surface Transportation Reauthorization Policy Statement

- Discussed how to communicate policy statement. Members agreed to share trade organization contacts to
  invite to a press release. A visit to Congress to meet with key transportation legislators is also planned.
- It was agreed to distribute this statement and schedule the next RSTAC meeting in April 2003.
