WEEKLY REPORT OF BNSF RAILWAY COMPANY

BNSF Railway Company ("BNSF") provides the following sixth weekly status report in response to the Board's Order of June 20, 2014 in the above referenced sub-docket. The Board's Order requests weekly status reports containing the following metrics by state: (a) running total of outstanding grain car orders at the end of the week; (b) total number of new orders for the week; (c) total number of orders filled for the week; (d) number of orders cancelled by shippers for the week; (e) number of orders cancelled by BNSF for the week; and (f) average number of days late for all outstanding grain car orders. The Board's Order also asks for the number of cars allocated to grain car service each week, including private cars in service.

Included herein is the weekly update on the performance measures contained in (i) Attachment A reflecting our efforts to resolve the backlog of grain orders from the prior harvest; (ii) Attachment B reflecting BNSF's progress as measured against the past due glide path previously provided, and (iii) Attachment C showing the distribution of past due shipments based on the number of days delayed beyond the want date. All data has been updated through the morning of July 31, 2014.

On July 24, 2014, Senator John Thune wrote to the Board encouraging the Members to require additional reporting on the average turn rates for grain shuttles in the weekly report on

past dues. BNSF has been providing certain weekly information on the average shuttle trips per month (TPM) for our shippers on our website since before 2014. The Board and other interested parties can access our current and future customer shuttle TPM communications on our Service Overview page (<u>http://www.bnsf.com/customers/service-page/</u>) under "Recent Updates."

We will continue to provide weekly updates of Attachments A, B and C pursuant to the schedule in the Board's June 20, 2014 order and to communicate frequently with our customers to ensure that they understand our service situation and that we hear specific feedback.


Car orders become past due when they are greater than 3 days past the desired want date
