Dear Chairman Elliott, Vice Chairman Miller, and the Honorable Ms Begeman:

I am writing in response to the Board's Order in Docket No. EP 724 (Sub-No. 2) dated June 20, 2014 as well as the recent order dated August 18, 2014 directing Canadian Pacific Railway Company (CP) to produce a grain order backlog plan and provide weekly status reports on various metrics. This is CP's Thirteenth Weekly Report.

For Week 6 of the 2014/15 crop year, new requests totaled 1400, including those on the Rapid City, Pierre & Eastern Railroad (RCP&E). We fulfilled 2403 grain orders this week which is a strong performance. Orders fulfilled exceeded new requests by 1003. Of the total orders fulfilled, 216 orders related to the RCP&E. This data is set forth at Appendix 1. In addition, CP continues to provide the RCP&E additional locomotive power. See, Appendix 2.

As of Grain Week 6, the number of open grain car requests is 5,583. Of these requests 3,480 will be serviced through our existing car request program. The remaining 2,103 requests represent cars that will move in dedicated train service. We anticipate that the number of open requests will continue to come down over the coming weeks.

Please note that Appendix 1 has been modified to make our reporting clearer as well as to add information related to the performance of shuttle trains in our dedicated train program.
