Re: STB Docket No. EP 724-3 - United States Rail Service Issues- Data Collection

Dear Chairman Miller, and Vice Chairman Begeman:

I am writing to provide comment on the service data that we are filing contemporaneous herewith in response to the Board's data collection order of October 8, 2014.

Of note this week, our outstanding grain car orders are down to 40. We fulfilled a total of 1984 grain car orders this reporting week, and received 567 new grain car orders. Taken as a whole, these metrics indicate a softening in the grain market.

As you are aware, the Chicago Terminal is currently experiencing congestion due to the effects of a major snow storm this past Sunday. We are taking appropriate countermeasures, and are working with other carriers to mitigate the situation.

With respect to the Rapid City, Pierre & Eastern Railroad (RCP&E), RCP&E made a request for 175 grain cars this week but reduced that to 122. We delivered 122 grain cars to them. On average this reporting week there were 0.4 more CP locomotives on RCP&E than RCP&E locomotives on CP, which is in balance.
