Re: STB Docket No. EP 724-3 - United States Rail Service Issues- Data Collection

Dear Chairman Miller, and Vice Chairman Begeman:

I am writing to provide comment on the service data that we are filing contemporaneous herewith in response to the Board's data collection order of October 8, 2014.

Of note this reporting week, our outstanding grain car orders are now at zero. We received 364 new grain car orders this reporting week, and spotted a total of 1613 grain cars, which total includes single cars and cars in dedicated trains. Taken as a whole, we are current in the United States from a grain order perspective.

With respect to the Rapid City, Pierre & Eastern Railroad (RCP&E), RCP&E made a request for 76 grain cars this week and we delivered 76 grain cars to them. On average this reporting week there were three more RCP&E locomotives on CP than CP locomotives on RCP&E, which is consistent with the level of demand on RCP&E.
