Dear Chairman Miller and Vice Chairman Begeman:

I am writing to provide comment on the service data that we are filing contemporaneous herewith in response to the Board's data collection order of October 8, 2014.

Overall our US network is fluid and in good operating condition. Like last week, our system average train speed, weekly average terminal dwell, and cars on line metrics are good. The spike in car inventory at Bensenville (Chicago) that we mentioned last week has improved. Car inventory at Bensenville is within normal operating parameters as of this writing.

Our outstanding grain car orders remain at zero. We spotted a total of 1475 grain cars this reporting week, which total includes single cars and cars in dedicated trains, and we received 557 new grain car orders. From a grain order perspective, we continue to remain current in the United States.

With respect to the Rapid City, Pierre & Eastern Railroad (RCP&E), RCP&E did not request any grain cars this week and we did not deliver any to them. On average this reporting week there was a plus six locomotive balance, meaning there were six more CP locomotives on RCP&E than RCP&E locomotives on CP.
