Dear Mr. Elliott, Ms Begeman and Ms Miller:

I am writing to provide comment on the service data that we are filing contemporaneous herewith in response to the Board's data collection order of October 8, 2014.

CP's US network continues to be fluid and in good operating condition, as it has for months. Again this week, system average train speed, weekly average terminal dwell, and cars on line data are all good.

The number of outstanding grain car orders has returned to zero this reporting week, where it has been for all but four of the last 37 weeks. We spotted a total of 1952 grain cars this week, which total includes single cars and cars in dedicated trains, and we received 783 new grain car orders. From a grain order perspective, we remain current in the United States.

The Rapid City, Pierre & Eastern Railroad (RCP&E) did not request any grain cars this week. We are unable to provide the CP/RCP&E average locomotive balance this reporting week because the person who assembles this data is ill. The data is compiled manually. We hope to supply the data with next week's filing.
