WITNESSETH:

1. Owner and Charterer are parties to that certain Master Bareboat Charter Agreement and Schedule 001 thereto each dated as of September 15, 2009 (collectively, the "Bareboat Charter").

2. Pursuant to the Bareboat Charter, Owner has agreed to let and demise to Charterer, and the Charterer has agreed to hire from Owner, thirteen (13) United States documented inland river hopper barges as identified on Schedule 1 attached hereto (hereinafter, the "Vessels").

3. The Bareboat Charter with respect to the Vessels became effective as of the date set forth in paragraph 1 above and shall be subject to a Term, as such term is defined in the Bareboat Charter.


